# Top Army commanders to review security challenges in J&K amid civilian killings, situation along LAC

New Delhi. Top commanders of the Indian Army will carry out an extensive review of the country's security challenges, including in eastern Ladakh as well as other sensitive areas along the Line of Actual Control (LAC) with China, at a four-day conference beginning Monday, people familiar with the development said.

The commanders will also deliberate on the security scenario in Jammu and Kashmir in the backdrop of a spate of civilian killings in the Union Territory in the last few weeks, they added. The conference will take place in Delhi. The people cited above said Chief of Army Staff General MM Naravane and the top commanders will review the country's combat readiness in eastern Ladakh where Indian and Chinese troops have been locked in a bitter standoff for 17 months, though the two sides have completed disengagement at a number of friction points. They said the Army commanders are also likely to discuss the possible impact of the Taliban's takeover of Afghanistan on the security of India and the region. "The second Army Commanders' Conference of 2021 is scheduled from October 25 to 28 at New Delhi. Army Commanders' Conference is an apex level biannual event which is held in April and October every year," the Army said in a



statement. The conference is an institutional platform for conceptual-level deliberations, culminating in making important policy decisions for the Indian Army. "The apex leadership of Indian Army will brainstorm on current and emerging security and administrative aspects to chart the future course for the Indian Army in the backdrop of the situation along the borders and challenges imposed by Covid-19 pandemic," the Army said.

Defence Minister Rajnath Singh is scheduled to address and interact with the top commanders of the 13 lakh-strong Army. Chief of Defence Staff General Bipin Rawat, Navy Chief Admiral Karambir Singh and Chief of Air Staff Air Chief Marshal VR Chaudhari are also scheduled to address the senior leadership of the Indian Army on avenues for promoting tri-service synergy, the Army said. The Army commanders are also expected to deliberate on various reform measures recommended by separate internal committees, the people said. They said the discussions on the situation in eastern Ladakh and ways to further bolster India's military preparedness in the region are likely to dominate the conference. The eastern Ladakh border standoff between the Indian and Chinese militaries erupted on May

5 last year following a violent clash in the Pangong lake areas and both sides gradually enhanced their deployment by rushing in tens of thousands of soldiers as well as heavy weaponry.

The tension escalated following a deadly clash in the Galwan Valley on June 15 last year. As a result of a series of military and diplomatic talks, the two sides completed the disengagement process in the Gogra area in August and in the north and south banks o The last round of military talks on October 10 ended in a stalemate, following which both sides blamed each other for the impasse. In a strong statement after the 13th round of talks, the Indian Army said the "constructive suggestions" made by it at the negotiations were neither agreeable to the Chinese side nor could Beijing provide any "forward-looking" proposals. Each side currently has around.

## Fact Check: Visual from PM Modi's rally passed off as protest in Assam against Bangladesh violence

The anti-Hindu violence in Bangladesh has triggered strong reactions across the border in Assam and West Bengal. Thousands of people gathered at Assam's Barak Valley recently to protest against the targetted attacks against minorities in Bangladesh. Amid this, an image of a massive gathering is viral on social media with the claim that Hindus from all over Assam have assembled at the Bangladesh border against the violence

The claim in Bengali translates to, "Massive tension along the Assam-Bangladesh border! Hindus from Barak to Guwahati have risen to protest the ongoing mass murder of Hindus in Bangladesh. Red alert issued along the India-Bangladesh border and Muslim areas near the border. Hail Lord Rama. Wake up Hindus. #SaveBangladeshiHindus" India Today Anti Fake News War Room (AFWA) has found that this particular picture is from Prime Minister Narendra Modi's 2019 rally in Mangalore, Karnataka. Also, Assam Police have sounded an alert recently but that is due to possible terror strikes by Pakistan's Inter-Services Intelligence (ISI) and terror outfit al-Qaeda. The archived versions of the posts are saved here and here.

Tracing the sea of saffron Using reverse image search, we found that the viral image was posted by several Twitter users in April 2019. These users had claimed that it was a visual of massive crowds that had gathered to listen to PM Modi on April 13, 2019, at Nehru Maidan in Mangalore. As per news reports, PM Modi was canvassing for BJP before the Lok Sabha polls that year. The media outlets also published several pictures and videos of a similar crowd. But we could not find the viral picture in any media report. So we tried to geo-locate the place and identify the elements in the photograph with the original ground where the rally was organised. In the viral image, we can see a two-storied building at the far end of the ground. We tried to locate this building in the videos and images of the Mangalore rally. We found a similar twostoried building in one of the rally visuals

#### Active COVID-19 Cases In India **Decline To 1,67,695**

New Delhi: India logged 14,306 new COVID-19 cases, taking the virus tally to 3,41,89,774, while the active cases declined to 1,67,695, according to the Union Health Ministry data updated on Monday.

The death toll climbed to 4,54,712 with 443 daily fatalities, according to the data updated at 8 am. The daily rise in new coronavirus infections has been below 30,000 for 31 straight days and less than 50,000 daily new cases have been reported for 120 consecutive days now. The active cases comprise 0.49 per cent of the total infections, the lowest since March 2020, while the national COVID-19 recovery rate was recorded at 98.18 per cent, the highest since March 2020, the ministry said. A decrease of 4,899 cases has been recorded in the total active number of COVID-19 cases in a span of 24 hours. The daily positivity rate was recorded at 1.43 per cent and the weekly positivity rate was also recorded at 1.24 per cent, according to the ministry. The number of people who have recuperated from the disease surged to 3,35,67,367, while the case fatality rate was recorded at 1.33 per cent. The cumulative doses administered in the country so far under the nationwide COVID-19 vaccination drive has exceeded 102.27 crore. India's COVID-19 tally had crossed the 20-lakh mark on August 7, 2020, 30 lakh on August 23, 40 lakh on September 5 and 50 lakh on September 16. It went past 60 lakh on September 28, 70 lakh on October 11, crossed 80 lakh on October 29, 90 lakh on November 20 and surpassed the one-crore mark on December 19
