The Outbreak of pandemic CoVID-19 across the globe and in India has impacted Company's operation by the way of interruption in its core activities, supply chain and availability of Manpower. As per the instructions of the Central Government, the Company had to shut down its Office/Shop for prohibiting the spread of the virus, from date 23rd March, 2020. It started with one day Janta Curfew and was preceded by 21 days nationwide lockdown from 25th March, 2020 to 14th April, 2020. Significant decline in the economic activity of the whole nation and the disruption created across the businesses have affected the operation of the Company as well as, the impact whereof would evolve around the developments taking place in forthcoming months.

Further the Company expects to recover the carrying amount of all its assets including inventory, receivables and loans in ordinary course of business based on information available on current economic conditions. The Company is continuously monitoring any material change in future economic condition for taking corrective actions within its purview and would keep assessing the impact for taking appropriate cognizance in financial reporting in the forthcoming quarters.

The Company resumed its partial operations by way of procuring orders through digital means of communication w.e.f. 4th May, 2020 and since then the operations are stabilizing. However, the administrative work of the company is still being done through "Work from Home" mode as the office falls under the Red Zone Area.

It is worthwhile to mention that legal compliances have always been the topmost priority of the Company and its management and the Company ensures that all available information about the impact of these events on the company and its operations is duly communicated in a timely manner to its investors and shareholders.
